## Project Overview

Balfour Beatty are delighted that works on the Cromer & Mundesley Coastal Management Schemes are progressing well. These essential works are being delivered by Coastal Partnership East on behalf of North Norfolk District Council and are being funded by the Environment Agency with NNDC and Mundesley Parish Council, contributing to Mundesley only. The Schemes will protect 600 local homes and businesses from flooding and coastal erosion.

Overview of project works are as follows:

### **Cromer Coastal Defence Scheme:**

These works involve the construction of a new rock armour revetment on the west side of Cromer pier, with 38,000 tonnes of rock placed on the shoreline. It will also include repair and installation works to: groynes; navigation beacons; concreting works, rock revetment and access improvement works.

### **Mundesley Coastal Defence Scheme:**

This will involve 30,000 tonnes of rock being placed on the shoreline to form a rock berm and a temporary rock stockpile. The team will also reinforce the existing coastal protection infrastructure and refurbish the groynes and navigation beacons. Work will see a rock berm – used to absorb the energy from the waves - in front of the already existing steel frame structure (west beach) and will also involve concrete works.

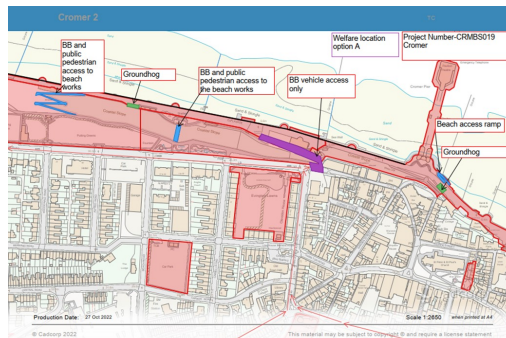
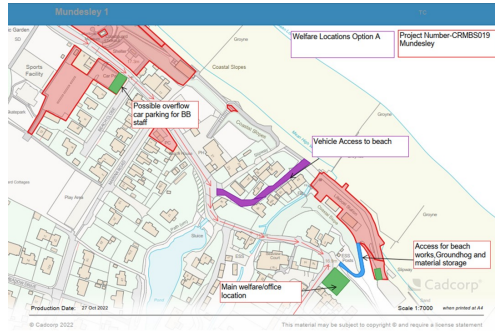

Concrete works at both Cromer & Mundesley are progressing well and we anticipate concrete works in Cromer to be completed this month. The delivery, recovery & placement of the rock that has been transported by boat from Scotland is continuing at both locations.

# Milestone progress

### August 2024

Continued deliveries of rock armour from Glensanda in Scotland via boat. Rock revetment works in Cromer completed in first bay to the west of the pier. Access to the beach in the second and third bays (west of pier) will be closed at key times in August.

### September 2024

Completion of the rock armour deliveries.

### October 2024

Rock armour placement along the beaches of Cromer and Mundesley continues through to the end of the year.

### December 2024

Continue with concrete works along the Mundesley beach front and completion of Cromer works are achieved.

### July 2025

Site demobilisation

# Site operating hours:

**Monday to Friday 0700-1800**

**August 2024:** Continuous rock deliveries 24/7 from the start of June through to September.

The sites main operating hours above are set to confine construction works to these hours. There are however times that we may need to work outside these times if it becomes absolutely essential to complete a specific activity. These will of course be agreed with North Norfolk District Council. Activities will be restricted so as not to disrupt the local community.
