

**THE NORFOLK COUNTY COUNCIL**  
**(WELLS-NEXT-THE-SEA, MARKET LANE, WAVENEY CLOSE)**  
**(PROHIBITION OF WAITING) ORDER 2023**

The Norfolk County Council propose to make the above Order under the Road Traffic Regulation Act 1984, the effects of which will be to prohibit any vehicle to wait – i) at any time along the lengths of road specified in Schedule 1 below; and ii) on Monday to Friday between 0800 hrs and 1600 hrs along the length of road specified in Schedule 2 below, unless being used in connection with a funeral.
